Post 021 is continuing to strive to meet their goal of 100 members. Membership retention is 94% and they are averaging 1.5 new members per month.

Post 23 is working on getting the remaining unpaid members up to date.

Post 2018 has 48 Members on the roster, 56 in the Ladies Auxiliary, 29 AMVETS Riders and 19 Sons of Amvets.

PROGRAMS

Post 001 is planning a Veterans Resource pamphlet for veterans in their community. They also publish a Quarterly Newsletter and reach out to members in need.

Post 021 veteran support activities includes but is not limited to: lawn mowing, military funerals, the Flags over Athens program, an Annual Horse, Pony and Mule Show fundraiser, driving veterans to medical appointments, working at the Athens Veterans Museum and fundraising for the Post.

Post 023 has a Rattlesnake Rodeo fundraiser each year and honors a Police Officer of the Year from the surrounding communities. There is a Spring fundraiser held each year.

Post 2018 has logged 1,165 service hours resulting in a total program value of \$60,170 during the five-month period from January 1st through June 10th, which includes \$10,000 from the Riders Chapter.

SERVICE

Post 23 members do volunteer work at the Veterans Memorial Scenic Overlook throughout the year and continue to work on the placement of a handicap access ramp at the site. The Post takes part in an ROTC Awards program for local schools. On Memorial Day flags were placed at over 700 graves in the local area.

Post 2018 does monthly visits and programs are conducted at the William F. Green VA Hospital. Post members volunteer weekly to help a non-profit Veterans Indoor Yard sale to raise funds for 501c19 Veterans organizations. Bi-weekly maintenance is provided for a neighborhood commons area partially owned by Veterans. The Post has been meeting with a local Boys Scout troop to assist them with a new charter to be sponsored by AMVETS Post 2018. A Memorial Day Celebration and shrimp boil was held on 5/30/22 with over fifty people attending.

UPCOMING EVENTS

Due to COVID restrictions Post 001 does not have any in person events scheduled. However, Zoom membership meetings are scheduled.

Post 021 holds a veteran's breakfast on the second Saturday of each month, participates in the Flags over Athens on Memorial Day, 4th of July and Veteran's Day. Fundraising and membership drives occur at the Post every Friday. The Themed Dinners, Karaoke Night and the Speaker Series have resumed.

Post 2018 will hold Bingo every week on Thursday nights. Fish fry's will be held each Friday night. Monthly visits to the W. F. Green Veteran's Hospital will continue. The annual Veteran's Day Parade will be held in Elberta and flags will be placed on Veteran's graves. The Post will participate in the Town's Thanksgiving Dinner and provide gift cards to Veteran families in need.

Post 023 has a monthly meeting every 2nd Thursday and a Quarterly newsletter is sent to the membership. A Veteran's Day Pancake Breakfast will be held at the Opp Senior Center.

MEMBERSHIP

Department of Georgia membership is off to a good start. The Department of Georgia has seen its membership increase since the COVID phase has passed. Since October 1, 2022, Georgia has recruited or renewed 166 members to our membership count. Georgia is growing its membership through the free membership program available to all women Veterans using grant money made available to the National Women's Veterans Council. Though we are making gains, we are still well short of our membership count from 2022. Department First Vice Commander Banks has asked each post to have a membership drive before the end of this reporting period. Department Commander Milton Allen has tasked all AMVETS members to recruit at least one new member so that the Department of Georgia would have more than 2,000 members by June 2023. At our September SEC meeting, the Department First Vice Commander had a workshop to re-train or teach all First Vice Commanders about the membership program and online system. National Riders Chaplain Jeremiah Botkins and Department President Kevin Ashe have been actively pursuing new Riders and Supporters membership so they can form another Chapter. Commander Milton Allen is continuing his recruiting efforts and encouraging Posts to increase or start a Sons Squadron at their post.

UPCOMING EVENTS

The Department of Georgia's next SEC meeting will be January 21-22, 2023, in Warner Robins, GA. Post 607(Valdosta will be hosting the District III meeting February 3-4, 2023, in Valdosta, GA.

PROGRAMS

Department Second Vice Commander Wanda Allen held a workshop during September SEC for all Post Commanders and Second Vice Commanders to inform them of the changes to Programs reporting online. Currently, we have 86% of our Posts reported in this Program reporting period. And with Veterans Day, we expect to have all Posts reporting by the end of November. Veterans Day proved to be a huge opportunity to accomplish many program hours for the Department of Georgia. Commander Milton Allen participated in Georgia's 41st Annual Veterans Day Parade. LEGISLATIVE

The Department of Georgia is teaming up with NSO Bobby Rand to ensure Veterans know how to take advantage of their benefits using the PACT Act and the listed presumptive. Also, NSO Bobby Rand is making sure our AMVETS and their family members affected by the Camp Lejeune [...]

[...] water contamination are getting the proper advice before entering into any agreements with lawyers to file lawsuits.

SERVICE

The Department of Georgia Service Foundation is still instrumental in supporting Posts with funds to make their upcoming events a success. The Service Foundation recently approved a monetary allowance to make it possible for the Department of Georgia to publish a website.

MEMBERSHIP

Membership is up at all posts. The Dept. of TN currently has 18 Posts totaling 2078 members. This includes 91 new members since Aug. 1 (45 life members / 46 Annual members). We continue to investigate new methods of recruitment, with retention being the focus.

The average age of our current membership is 68, but average age of our 'new' members is 57 stressing the need to recruit and pay attention to the needs of our younger members. Also of note is the ratio of female/male new recruits into military service and the need to recruit women veterans into AMVETS. Of our new TN AMVETS members, 12 are women.

We are proud to announce the opening of our new AMVETS Post 325, in Murfreesboro, TN

The membership committee has spent the last few months scrubbing the Member at Large (MAL) list, finding 173 of the 679 MAL's listed were deceased. We also recognized that many of our veterans' applications, made online, were accepted without listings of their branch of service or phone number.

PROGRAMS

Program tracking remains integral throughout our posts. Awaiting the new 'program reporting' system, at National, TN Posts are encouraged to submit program reports to the Dept 2nd Vice, on a monthly basis. These individual Post reports are then compiled and forwarded to National. Assistance is available, thru the Department, for Posts having difficulty in the reporting process to facilitate and maintain accurate State records.

Through our Americanism Program, our posts distributed 37,649 pocket constitutions to 8th grade students throughout 24 counties of TN. We hope to increase that number, engaging students in more of our counties, next year.

4 TN students attended the Freedom Foundations, Spirit of America Youth Leadership Conference, Nov 3-6, 2022 at Pigeon Forge. 3 of the students' trips were funded by the TN State Service Foundation. The 4th was funded by AMVETS National Service Foundation. All posts are encouraged to stress the relevance of Americanism to our students this coming year, distributing and turning in Americanism Packets before the Spring S.E.C. The Annual Dept of TN Golf Tournament, in Etowah, TN was a huge success thanks to Post 100, the 20 teams who participated and all who assisted with the coordination and running of the event.

SERVICE

Tennessee Posts remain active assisting veterans in need: building ramps; assisting in home repairs; providing transportation; procuring medical equipment; assisting in storm and disaster relief efforts, as well as providing socialization activities by visiting hospitals and nursing facilities.

With the approaching Holiday Seasons, our posts are actively addressing the nutritional needs of our less fortunate veterans, preparing food baskets and gifts for these local veterans.

We offer online capabilities to join IL Amvets and our cutting-edge website sets us apart from others. Illinois Amvets is constantly trying to improve our coverage and remain at the forefront of Illinois veterans' organizations.

PROGRAMS

The AMVETS Department of Illinois reached 100% programs reporting for this past year. In addition, Illinois AMVETS volunteers continue to work to provide volunteer events such as bingo, picnics, and the like. No program data is available due to the reporting link being inoperable.

SERVICE

The AMVETS Department of Illinois currently has 4 department VSOs located throughout the state. All VSOs are working thoroughly and effectively to assist veterans and their families proven by filing over 3,500 claims bringing in over \$52.5 million worth of benefits to the state of Illinois just this recent calendar year (2021). Our service officer program was 3rd in the nation in claims submitted during the Covid stricken 2020 year.

Our service officers recently held a town hall meeting at the Bloomington VFW post to inform veterans and family members about the newly signed PACT Act and why it is so important to go through a service officer and not the lawyers on T.V. plus many more topics associated with this act and what information is needed to either start their claim or get an old claim resubmitted. We had a great turn out for this event and are planning on having another one. We couldn't be prouder of our service officers, they are second to none.

LEGISLATION

The new 102nd Illinois General Assembly had a very busy Spring Session passing major veterans related legislation. A list of highlighted legislation is listed below. We plan on doing a joint legislative day in the spring 2023 to impact our legislatures and put forth many vet specific legislative items we would like updated or introduced. Minutes of the last SEC, and Agenda were adopted as printed in the News Paper. PNC Heun was recognized as being present.

Ladies Auxiliary President addressed the floor, if you want to start a new AMVETS Auxiliary let me know and I will be glad to help we have chartered 3 new Auxiliaries in KY so far this year, also I can help if you want to start a JR's at your post.

The Department IV Commander discussed not using TV lawyers for Camp Lejeune water claims; there were over 700 lawyers recognized to help with that. AMVETS was instrumental in getting all the major VSO's together except the American Legion who wanted to go it alone to get the Pact act passed, Commander wants a letter drafted and signed by all KY post commanders to National HQ stating we want people working at National HQ every day we can never get in touch with anyone about anything, and calls are never returned, computer system is of no use to us and coms are almost nonexistent.

PNC Heun addressed the floor, National has approved to get a new computer system up to \$500,000, but you can't just buy one off the shelf, it has to be custom designed and programmed for our specific needs and this takes time. There is a new phone system in place that updated from 250,000 phone calls a day to 1,000,000 phone calls a day to make sure everyone that leaves a message gets their calls returned. Everyone AMVETS, Auxiliary, Sons, Jr's and riders will all be on one computer system, a push has come from all departments to have all AMVETS National employees back to work full time.

Department 2nd Vice Commander gave a report: make sure you get your program reports to me so I can get them to National, you can count those who wear red shirts on Friday as 8 hours per person, events with other VSO's, VFW, AL etc. can count as program hours.

JEVCO report was given. We are working on a new veterans nursing home in Bowling Green KY.

NEC report was given and adopted

Finance report was given and adopted

Suicide prevention chairman gave report I can't find or get anything from national, the latest information I could get was from 2020 report adopted.

Service officer west gave a report, no staff or medical personnel have died of covid at the veterans nursing homes but 4 patients have, we can't visit nursing homes in person now, but have meetings by email and zoom.

The hat was passed and \$186.00 was collected for the ladies scholarship program

Report of Robert E. Lee

Department: Missouri

National Commander, National Officers, Members of the National Executive Committee, and Fellow AMVETS:

Membership:

1. The Department of Missouri currently has 29 active posts with a total of 2928 current members (357 annual and 2571 life members).
2. The Commanders and 1st Vice Commanders of Membership at the Posts are encouraged to work on pursuing annual renewals for the 876 members that expired on 8/31/2022 and the 307 members whose membership expired on 8/31/2021. These additional 1183 Veterans would bring membership up to 4111! For a secondary project, these members will be contacted to encourage re-joining the organization.
3. There are opportunities in areas within the Department to establish posts that are being evaluated and considered.

Programs:

1. Total programs for the 2021 calendar year were as follows: 8,849 volunteers that performed 41,987 hours in services that covered 420,647 miles. These services were valued at \$1,598,612.91!!
2. For the last reporting period which ended on June 30, 2022, there were 30 out of 30 posts (100%) that reported via the paper programs reporting form on account of the online access being down for upgrades. These reports included 3520 volunteers who performed 18,689 hours in services that covered 118,893 miles. These services were valued at \$590,305.92.
3. Programs reporting via the PDF forms are slowly trickling in for the reporting period which started on July 1, 2022. To date, 3 of the 29 posts have submitted at least 1 program. There have been many great programs and events that need to get reported. Near the end of the reporting period, all programs reporting forms will be submitted via email to National as a Department package.

Service:

1. The Department of Missouri has 3 Service Officers in the St. Louis area to assist with Veterans and VA claims. The Department is currently seeking a replacement for the Service Officer lost in the Kansas City area along with filling the positions in Columbia and Poplar Bluff. The Service Foundation is looking to also add a Service Officer in the Springfield/Willard area. There is a candidate for the Columbia VA but finalizing is dependent on the current COVID-19 Pandemic. A part-time service officer is being trained for placement into the City Hall in O'Fallon. The long-term plan is to have a Service Officer in each of the 5 VA Hospitals in Missouri.
2. The Commander's Project is to fundraise for AMVETS National Convention which is scheduled to take place in St. Charles, MO, in August 2025 and to grow membership and posts in the KC area.
3. Ongoing projects continue to include military funerals, homeless Veterans, supporting Veterans Hospitals and homes, and supporting JROTC and ROTC programs.

Upcoming Events:

1. Our upcoming SEC meetings will be held at the Inn at Grand Glaize in Osage Beach on the following dates: February 4-5, 2023, and April 15-16, 2023.
2. Our 78th Annual Dept. Convention will be held on June 3-4, 2023, at the Inn at Grand Glaize.

Legislation

1. **Senate Bill 882 – EFFECTIVE DATE AUGUST 28, 2022:** Sponsored by Senator Bill White (R-Joplin, MO) with information released to the media on January 6, 2022. On March 9, 2022, the Seniors, Families, Veterans, and Military Affairs Committee voted to pass this bill.

This act modifies and establishes provisions relating to military affairs, including Vietnam Veterans Day, Missouri Orange Heart Medal, information of services of state agencies for veterans, school choice for students of military families, and professional licensing informational webpage for members of the military.

- a. VIETNAM VETERANS DAY (SECTION 9.085)
 - i. Currently, Vietnam Veterans Day in Missouri is celebrated on March 30th of each year. This act modifies the date to March 29th of each year.
 - ii. This provision is identical to a provision in SCS/HB 2455 (2022).
- b. MISSOURI ORANGE HEART MEDAL (SECTION 41.589)
 - i. The Governor is authorized, upon recommendation of the Adjutant General, to present the Missouri Orange Heart Medal to individuals who were members of the Armed Forces that served in the Vietnam Conflict and were subsequently affected by exposure to Agent Orange during their military service. Not more than one Missouri Orange Heart Medal shall be awarded or presented to any one person and nor shall the Missouri Orange Heart Medal be awarded to or retained by any person who separated from service under dishonorable conditions. The Missouri Orange Heart Medal may be presented to the surviving primary next of kin in the event of death of any individual subsequent to his or her service who would be entitled to the Missouri Orange Heart Medal.
 - ii. This provision is identical to a provision in SCS/HB 2455 (2022).
- c. INFORMATION OF SERVICES PROVIDED BY STATE AGENCIES FOR VETERANS (SECTION 42.051)
 - i. Currently, every state agency is required to ensure that any new or modified form used to collect data from individuals include questions to identify veterans and provide information and assistance to any requesting veterans. This act modifies the questions to include immediate family members. Additionally, this act provides that the Governor may maintain a website consisting of the information provided to veterans and immediate family members of veterans from any state agency.
 - ii. This provision is identical to a provision in SCS/HB 2455 (2022).
- d. SCHOOL CHOICE FOR MILITARY FAMILIES (SECTION 167.020)
 - i. If the parent or legal guardian of a pupil is an active-duty member of the Armed Forces of the United States, the parent or legal guardian may register the pupil with the school district and the school in the school district of the parent's or legal guardian's choice if certain documentation is provided. Unless otherwise required by law, this act shall not require a school district to provide transportation services to a pupil registered in a school district chosen by a parent or legal guardian if the pupil would not otherwise be registered in the school district and school in the school district according to current law.
 - ii. This provision is identical to a provision in SCS/HB 2455 (2022).
- e. DIVISION OF PROFESSIONAL REGISTRATION INFORMATIONAL WEBPAGE FOR MILITARY MEMBERS (SECTION 324.001)
 - i. This act requires that the Division of Professional Registration shall maintain an easily accessible webpage containing the Division's rules, regulations, and procedures related to the professional licensing of members of the Armed Forces of the United States, honorably discharged veterans, and spouses of such members or veterans.
 - ii. This provision is identical to a provision in SCS/HB 2455 (2022).

*There are no amendments to this bill.

1. **Senate Bill 941 – EFFECTIVE AUGUST 28, 2022:** Sponsored by Angela Mosley (D - District 13 – Part of St. Louis County). On March 2, 2022, hearing conducted by the S Seniors, Families, Veterans, & Military Affairs Committee.

This act provides that state employees in support care assistance positions for Missouri veterans' homes shall receive a wage in the amount of at least \$15 per hour and no more than \$22 per hour. The wage shall be effective on January 1, 2022, with an annual increase or decrease based on inflation every following year. ***There are no amendments to this bill.

1. **Senate Bill 1013 – EFFECTIVE AUGUST 28, 2022:** Sponsored by Senator Stephen Roberts (D – District 5 – Part of St. Louis City). On April 6, 2022, SCS voted “Do Pass” S Seniors, Families, Veterans, & Military Affairs Committee (4958S.02C).

This act modifies provisions relating to job training programs, including the Show-Me Heroes Program and Missouri One Start Program.

SHOW-ME HEROES PROGRAM (SECTION 620.515): This act provides that the Department of Higher Education and Workforce Development may award grants from the Show-Me Heroes Program or a program administering the Show-Me Heroes Program to one or more non-profit organizations that facilitate the participation of veterans and active-duty United States military personnel transitioning to civilian employment in apprenticeship training programs, as described in the act. The grant shall be used only to recruit or assist veterans or active-duty United States military personnel transitioning into civilian employment to participate in an apprenticeship training program in this state.

This provision is identical to a provision in the truly agreed to and finally passed SS/HB 2400 (2022) and in SCS/HB 2455 (2022). *There are no amendments to this bill.

1. **Senate Concurrent Resolution (SCR) 28 – EFFECTIVE MAY 3, 2022:** Sponsored by Senator Bill White (R – District 32 – Dade, Jasper, and Newton Counties). On May 3, 2022, the Rules, Joint Rules, Resolutions, and Ethics Committee voted to adopt.

This concurrent resolution urges the President of the United States to designate a state funeral for the last surviving Medal of Honor recipient from World War II.

This concurrent resolution is identical to HCR 58 (2022).

*There are no amendments to this resolution.

1. **Senate Concurrent Resolution (SCR) 28 – EFFECTIVE MAY 13, 2022:** Sponsored by Senator Bill White (R – District 32 – Dade, Jasper, and Newton Counties). On May 13, 2022, the Rules, Joint Rules, Resolutions, and Ethics Committee voted to adopt.

This concurrent resolution calls on the United States Congress to enact legislation allowing for the inclusion of the Newtonia Battlefields in the National Park Service through the expansion of Wilson's Creek National Battlefield in order to preserve the history of the Civil War.

*There are not amendments for this resolution.

1. **Senate Joint Resolution (SJR) 35 – EFFECTIVE UPON VOTER APPROVAL:** Sponsored by Senator Bill Eigel (R – District 23 – Part of St. Charles County). On January 26, 2022, voted “Do Pass” S Seniors, Families, Veterans, & Military Affairs Committee.

This proposed constitutional amendment, if approved by the voters, creates the Department of the National Guard, which shall consist of the Adjutant General and shall administer the militia and any programs relating to military forces.

This amendment is identical to SCS/HJR 6 (2021) and is similar to the truly agreed to and finally passed HJR 116 (2022), SJR 7 (2021), SJR 59 (2020), and HJR 103 (2020).

1. As of December 2021, there is a proposed resolution to the Missouri Constitution (submitted by Sen. [Tony Luetkemeyer](#) and Rep. [Ashley Aune](#)) for property tax exemptions for veterans with total service-related disabilities. Should it pass the legislature (session began January 5, 2022) and make it to the ballot, the question would appear as this: "Shall the Missouri Constitution be amended to exempt veterans of the Armed Forces with a total service-connected disability from property tax on the veteran's real property?"

We will be the ones who will help them get through their low points. This program will also bring veterans together through AMVETS to do activities to help bring that camaraderie back that some veterans may be missing. The sounds, smells, sights, and feelings of war are something that veterans know all too well and will never forget. Because of that reason, we all came back a little different than before we went over. Many times, veterans cannot come home and talk freely to our families and friends about what we've went through while deployed. The burden of war sometimes causes us to withdraw from friends and family. It's during these instances of withdrawal that loneliness and depression set in. Many veterans try to reach out one last time to anyone who will listen...waiting for someone to validate them, their service, and their life. It's at this point that this program will be there to help them.

Together, we aim to bring down the number of veteran suicides and to bring awareness to PTSD. In doing so, we will help to defeat the stigma around mental health issues. Our veterans didn't fail us while defending our country and we will not fail them when they need us most.

The End of Legislative Session 2021-2022 was September 30. Reeb Government Relation has been working on behalf of the AMVETS with the California Legislature to help improve the quality of life for Veterans and their families. During the 2022 legislative year, we worked on and monitored 90 military and veteran bills. A total of 24 of those bills were sent to the Governor, who has until Sep 30 to act on all Legislation. Before we get started, I wanted to note that on August 10 President Biden passed a comprehensive \$1.5 billion federal piece of legislation on presumptive toxic exposures. So, this will make it easier for all generations of veterans to receive care and benefits from the BA on tocsin issues. Seth's report says to include only those bills that were signed as it would be a 14-page legislative report if we listed all the bills that did not pass.

During the pandemic, the work, usually done by me in members visiting the capital offices has been relegated solely to Reeb Government Relations during the pandemic, as access to visit members has been denied previously and severely limited since the pandemic started. Special thanks to Seth and Dana for representing the state capital in making a full-on representation and for 1 million calls and emails to the legislature to support our bills. Have a great DEC it will be great to see all of you.

As of October 31, 2022, there was an amount of over \$222,000 in cash in the General, Growth, Pledge, and Metropolitan bank accounts and a total of \$71,458 in accrued expenses. NSF grant received as of October 31, 2022, was to the tune of \$100,000. The audit for FY 2020-21 was finalized on May 4, 2022, and form 990 for the FY 2020-21 was filled on time. The audit for 2021-22 is scheduled to start on January 15, 2023.

We have received revenue of \$325,324 thus far. The approximate income percentage breakdown is as follows: All grants and other income is 47%, and membership dues income is 53%.

Actual expenses totaled \$478,434. Expenses exceeded income by \$153,110. After Unrealized Losses, expenses exceeded income by \$417,222. The percentage breakdown of expenses is as follows: General and Administration 47%, and Programs Services 53%.

I want to thank the membership for allowing me to continue as the National Finance Officer this fiscal year, and I will continue to work for each of you and keep you informed of the state of AMVETS' financial status.

To ensure that it is not an overload only the upper states A-M will be accepted and certified at this time. Forms for the lower states N-Z will not be accepted until after July 31, 2023. The end of the 117th Congress...

And like that, another Congress is in the books for the AMVETS Legislative Team as of January 3rd, 2023. AMVETS has a lot to be proud of over the past two years. Some of our favorite moments include:

- ★ AMVETS hosting center stage at Rolling to Remember at the most pivotal moment for what ultimately became the passage of the PACT Act
- ★ AMVETS taking a firm stance alongside Senator Gillibrand for significant change in advocating for victims of Military Sexual Trauma
- ★ AMVETS remains the veteran organization that does not waiver in our commitment to lower and address the suicide epidemic
- ★ Commanders Jan Brown, and Greg Heun, proved their mettle as champions on Capitol Hill by providing powerful testimonies. Proving AMVETS has a clear and intentional advocacy agenda for all of our Nation's Veterans

AMVETS efforts focused on the passage of the PACT Act resulted in Commander Heun and Executive Director Joe Chenelly standing in the East Room of the White House for the most significant signing ceremony in recent history. The PACT Act will be a game-changer for veterans. And while AMVETS played a critical role in the PACT Act, they continued to take the lead, by being the loudest voice, on the issues that are most negatively affecting the highest number of veterans, resulting in death and sexual trauma: mental health/suicide and military sexual trauma.

We are still working hard to get some bills across the finish line. However, we expect some movement of veteran-related legislation in the lame-duck session and will provide an End of Congress report in the next NEC update.

What the election means for Veterans

All in all, a pretty dull election as it relates to the committees. No Senators on SVAC lost their seats. Only one member, Elaine Luria, lost in the general election. For some perspective, 2010 resulted in all Democrats on HVAC other than 3 losing their seats (Corrine Brown, Mike Michaud, and Tim Walz). Major wave elections tend to disproportionately affect HVAC as they have historically had a lot of freshman members that have tended toward swing districts and districts with a high proportion of veterans.

In 2010, there was a net R gain of 63 seats in the house and 6 R seats in the Senate. This election doesn't even begin to approach that. Nonetheless, the Republicans will have what looks like a 3-4 seat, an extremely narrow majority, which will still change things up significantly for HVAC.

Additionally, with the loss of Rep Elaine Luria, the lead Dem seat on DAMA is open. Also, we can expect a fair amount of shake-up in membership of the committee regardless as most would not argue HVAC as a final destination committee of choice, unfortunately... This will especially hold for rank-and-file members not offered leadership positions on HVAC via their subcommittee.

With the House flipping to the Republicans, we anticipate they will be particularly interested in exploring suicide and mental health. This issue saw insufficient attention in the 117th Congress as the Senate and House generally supported traditional mental healthcare expansion programs that have proven ineffective for the past two decades, with high costs and an extraordinary lack of data supporting their outcomes.

We will provide another update once we get some sense of leadership selections/committee assignments at the beginning of the new Congress.

Thank you in advance for your continued support in my year as your 1st Vice Commander and I am pleased to present my first report from that position.

I attended two ceremonies as the presenter of employer of the year award to the North Carolina Department of Military and Veterans Affairs, Governor's Working Group and Employers Group individual award to Mr. Rodney Woody, this award was newly created in 2020 and a North Carolinian has won 3 years running. On October 27th, I was the keynote speaker for the 11th annual Salute to Veterans sponsored by the Rockingham Hospice Facility.

On the 9th and 10th of November, I was at national headquarters meeting with the membership department and with the National Commander.

This year we have a membership drive at National that involves the National Districts. The high recruiter of all six districts will receive round trip fare and four nights lodging at this year's National Convention in Pittsburgh, PA. Als, along with two tickets to both the Silver Helmet Banquet and the Commander's Banquet.

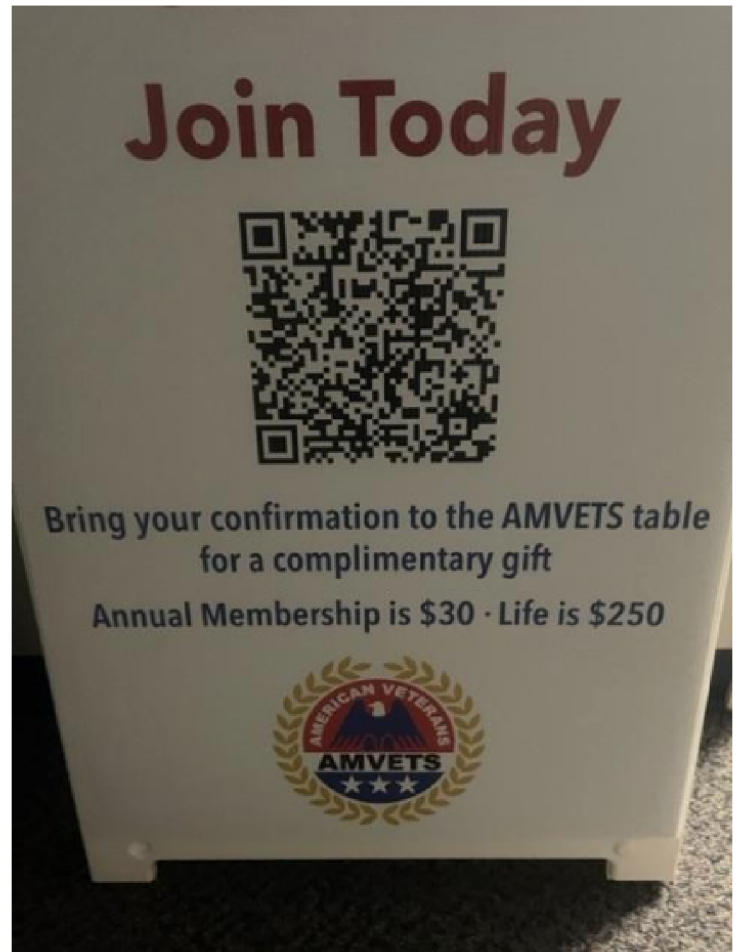

National Commander McLean, National Officers, members of the National Executive Committee and fellow AMVETS:

Your AMVETS National Headquarters continues working hard to best serve you, all our members, and the entire AMVETS Family.

The first quarter of this Membership year went quickly. Headquarters' financial health is improving, as our new Finance Department has regained full functionality. We hope every Departments' (state) leaders have seen the positive changes in the way membership refunds are paid.

Harry Neal retired after more than 10 years leading the national Membership Department. We thank him for his dedication to the organization. Membership is running well, and a new department leader will be in place in early 2023. We are preparing for the restructured Life Membership plan's implementation in September 2023.

Information Technology challenges persist, but we've made great strides in ensuring AMVETS' operating systems and databases are more secure and efficient than ever. HQ staff is preparing to move forward with a new database platform that will stay within the existing budget and improve ease of use for vice commanders across the nation.

By the time we meet on December 3, I believe we will have secured an approved hotel for the March NEC meetings, which are to include the AMVETS Legislative Advocacy Week and the Silver Helmet Gala. Also as discussed and approved at the National Convention, the hotel will be large enough to hold for our events and house all attendees. It will also be closer to Washington. The rooming rates will be higher than in past years. Inflation and the harm the pandemic restrictions and shutdowns imposed on the hospitality industry are catching up with everyone trying to hold conferences or dinners.

In seeking a new location, we only considered properties offering enough meeting space and room rates under \$200 per night. The BWI Marriott, where we held the NECs the past several years, is too small to host our Spring NEC meetings, given the Ladies Auxiliary and Sons of AMVETS also meet then. It also did not have a room large enough to hold the Silver Helmet.

Position: Chief Medical Executive

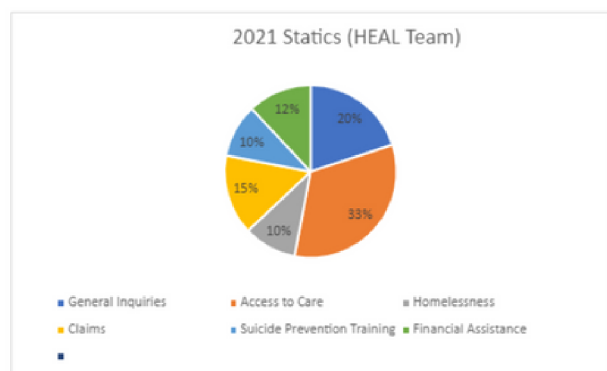
HEAL has been doing very well in 2022. We hosted a viewing of the “Unprescribed” Documentary in Kansas City, Missouri on April 19th, 2022, at the PlexPod Westport Commons. There was a panel discussion with cannabis advocates and legislators. This documentary brought awareness to veteran suicide and highlights the positive effects on veterans lives everyday.

The HEAL Program hosted the Annual 2.2 Mile Run/Walk for Rolling to Remember on May 28th, 2022, in honor of MIAs, POWs and Veterans we lost to suicide. The run was a success with over 100 attendants and over 5k engagements on Facebook.

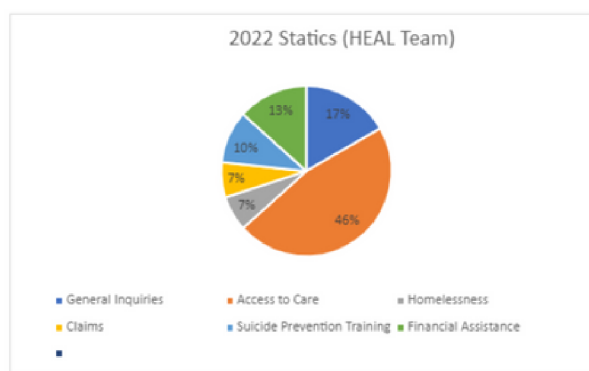
On June 27th, 2022, HEAL made history during a Healthcare Summit in Hawaii with PTSD awareness, suicide prevention, and cannabis research being the forefront of the conversation. There has never been a cannabis event held at a VA center in history. The event was located at the Tripler Army Medical Center in Honolulu, HI. We received interest from leaders across the country including Montel Williams and Dr. Sue Sisley who were our guest speakers.

HEAL also accompanied Steve Ellmore, the creator of the “Unprescribed” Documentary which shed light on alternative medications available for veterans as well as the importance and effectiveness of cannabis on Veterans in June 2022.

HEAL calls are experiencing a steady rise in veteran assistance. We have served over 150 veterans in 2022; a 33% increase from last years statistics and expected to increase another 20%. We are projecting up to 180 veterans assisted by the conclusion of this year. Below is a comparison of 2021 AND 2022 statistics for veteran interactions.

2023 Membership Renewals were emailed to the members who had email addresses, and those who didn't they were mailed via the postal service to the members. They were a little late this year going out. The 2023-24 year we will get them mailed to the members earlier. They cannot go out too early because of certain criterias. We are working on making it better for our members.

Our mission this year is to strive harder to educate our officers on how to enter and renew members. Work more with the Departments/Post on how important it is to apply monies to the members records asap. National get lots of calls from members who have paid their dues to the post and departments and the money have not yet been applied. And in a lot of cases it never does. National will have to give the members in some cases their membership when the posts and departments hold on to their money. We have a lot of duplicate/triple members in the data base and in some cases some members are in 5 times. The system doesn't generate cards for those members. We have to correct it, make cards for those members in house.

Our data base is full of members with Red xs, meaning there was no money applied to their record, The member cannot log into the website to pay their dues ect. National will have to correct it.

Our goal for the 2023-24 - Membership year with the members' cards is to have the cards sent to National Headquarters and we will separate them and mail them to the perspective post/departments. And the post will mail them to the members when their dues are paid. National have had to reprint cards (inhouse) that have already been printed by our printers. To cut down the cost of cards and postage we believe this will be the better way. It was done in previous years with no problems. Some post are giving the members their 2023 cards before they renew. That has created a lot of problems that National have to correct.

We will be holding our second zoom meeting a few days before the December NEC meeting. As we wind down to the end of the year as of right now, we have 15 Departments that have not had any posts reporting for their state which are: Rhode Island, District of Columbia, Maryland, West Virginia, Alabama, Arkansas, Iowa, Missouri, Kansas, Nebraska, Texas, Alaska, California, Hawaii, Oregon. I realize some wait until the last minute to send in the reports but the earlier the better. I ask that the National District Commanders to please contact their states in their districts and remind them to report their activities. Veterans Day I'm sure was celebrated in all states in some types of capacity, so don't forget to report those events.

Thank you to the Departments that sent student to Freedoms Foundation, 3-6 November 2022 and to the National Service Foundation/AMVETS Charities for Sponsoring those students, we couldn't have done it without your help. We had a small group of students, but they were mighty and represented us well, all had a great time. I encourage all states to send a representative from your state, The students get so much education out of this program, and they form new bonds with student from other states and make everlasting friendships. Some students have even come back as Chaperones.

We were lucky enough to have the Pennsylvania State Second Vice and The State Commander from North Dakota as chaperones this year as well as Dr. Kissel from California, thank you very much for participating. If you want to see what the program is like, volunteer to chaperone, once you see the program it will make you want to come back. There is a program next year in October 5-8, 2023, we are encouraging any State 2nd Vice or Americanism officers to attend to give you a firsthand experience of what the 9th Grade students will be going through in November. This is an AMVET program and as such the AMVETS should be more receptive to attending this wonderful event. Chaperone applications will be sent out if you are interested or please contact the Programs Team and we will get you the information.

We are currently receiving a lot of Eagle Scout requests and we are putting those on hold until 1 February 2023. So please let your states know this. We need to concentrate on the end of year program reporting volunteer hours and values.

Veterans Day I was in Maryland for the week and participated with The AMVETS National 2nd Vice and Riders National 2nd Vice in the wreath laying ceremonies at the WWII Memorial, Vietnam Wall [...]

[...] and the Korean War Memorial, as well as participated with the National Commander and Missouri State commander at laying the wreath at the Tomb of the Unknown Soldier.

VAVs REP/Dept appointments for the states of A-M. which ended 31 July 2022, some states have still not been updated and we are now in the process of reminding the N-Z states that they need to look at their REPs/DEPS to see if they need to be updated. Even if it is the same individuals, we need the new forms with the current state Commanders Signature and this year's date. The States A-M forms need to be sent to National now, the States N-Z need to be sent in by 21 July 2023 but the earlier the better so we can have them sent out to the VA locations by 31 July 2023.

Scholarships will be opening in January which is for Veterans, Spouses of and Grandchildren of Veterans we encourage those to apply. The Lowes Scholarship is also available to anyone that will be looking at going into the trade's profession.

The Career Center is doing a wonderful job:

AMVETS Career Center placed 230 veterans in the third quarter at a cost per placement of \$350.73. At that point, we successfully met a little over 77% of our annual 630 placement goal. Our full-time placements stood at 94% and our Post 9/11 veterans maintained at 77%. 86% percent who were placed stayed on the job more than 6months and 89% percent stayed for at least 12 months. With a steady 23% of women veteran placements, our team look forward to attending targeted women events to increase female veteran recruitment. The top three employment industries for those placements were Defense Contracting, Government, Business/Finance. The average salary was \$63,000.

As of today, the career center has placed 624 of our placement annual goal. It is projected that we will exceed the annual expectation.

Lastly, I would like to thank the National Commander and National Executive Director for coming out to Michigan for my Ceremony.

The newsletter goes out to a list of about 170,000 and those looking to sign up can do so by emailing media@amvets.org.

Projects

- Comms continues to work with My Front Page Story where Headquarters is able to highlight our members through a 'Veteran of the Month' release. This collaboration began in March 2022.
- AMVETS is revisiting our Futures 4 Forces campaign with Lowe's and WD-40. Comms is sharing in-house-created content as well as providing virtual meeting assistance for this partnership.
